

TITLE 2. ADMINISTRATION
Division 1. Administrative Personnel
Chapter 1. State Personnel Board
Subchapter 1.3. Classifications, Examinations, and Appointments
Article 14. Probationary Period.

§ 327. Cancellation or Withdrawal of Notice of Rejection.

The appointing power may cancel or withdraw a notice of rejection of a probationer in the following manner and not otherwise of rejection during probation: ~~(a)~~ by filing with the board Board ~~on or prior to the thirtieth calendar day after the effective date of rejection,~~ a written notice of cancellation or withdrawal setting forth the reasons therefore, ~~and (b) by obtaining the concurrence of the executive officer to such cancellation or withdrawal prior to such filing.~~ The written notice of cancellation or withdrawal shall be filed with the Board no later than 45 days after the effective date of the rejection on probation.

An employee whose probationary rejection is canceled or withdrawn shall, ~~for such time as the executive officer determines is necessary to prevent injustice to the employee,~~ be entitled to payment of salary less legal offsets, if any, and to credit for seniority, sick leave, vacation, and merit salary adjustment that he or she would have otherwise received but for the initial rejection on probation.

A cancellation or withdrawal of rejection shall be without prejudice to further rejection, punitive action, or disciplinary proceeding for the same or other reasons.
